that the Admitted Dues of the Applicant will be payable by Suraksha/Mazda jointly or severally;

Such other order and reliefs as the Hon'ble Tribunal may deem fit in the nature and circumstances of the case."

ORDER

We have heard all the parties concerned and perused all the documents submitted by them. This application has been filed as an Intervention Application to the Application bearing M.A. No. 3743 of 2019. Prayers 'a' seeking for intervention and 'b' for supply of copies are deemed to have been allowed by this Tribunal. The applicant has pressed for prayer 'c' of this application which seeks for clarification and declaration that the admitted dues of the applicant herein will be payable by Suraksha/Mazda jointly or severely in case the said M.A. 3743 is allowed by this Tribunal. It is pertinent to note here that we have dismissed M.A. 3743 of 2019 and therefore, nothing survives in this prayer as it is a conditional prayer. Thus, eventually, nothing survives in this application. Therefore, I.A. 1712/2020 is disposed of as infructuous.
